I. GENERAL TERMS & CONDITIONS OF TENDER:

1. Your offer should be in 2 parts viz.

PART 'A'- Technical Offer consisting of Technical & Commercial details in the format enclosed.

PART 'B'- Price Offer consisting of price on F.O.R Destination basis in the format enclosed..

PART 'A' - Technical Offer only will be opened on the Tender opening date.

PART 'B' of a party will be opened at a later date only when its technical part is accepted.

2. Technical offer Part 'A' will be opened @ 4.00 p.m. on the due date mentioned in the presence of Tenderers, whoever is present on the due date.

3. Price offer Part 'B' of technically suitable offers will be opened at a later date and eligible parties will be informed about the date of opening.

4. For Erection/Commissioning work, Power supply will be provided by TANMAG on chargeable basis. All other requirement like tools, tackles, man power, consumable, welding electrodes, gas etc. must be arranged by the supplier. Water will be provided free of cost.

5. TANMAG reserves the right to -

- (1) accept / reject any offer fully (or) partially.
- (2) to cancel the tender.
- (3) to award (or) not to award contract.
- (4) to operate risk purchase clause.

6. EMD requirement for each tender is as below.

7. EMD for a value as required above to be submitted by way of DD drawn in favour of **"TAMILNADU MAGNESITE LIMITED"** payable at SALEM from any bank should be enclosed in technical offer. EMD also can be paid by Bank Guarantee valid for 3 months from the due date.

- The EMD will be adjusted towards security deposited to be paid for executing the order.
- The EMD of unsuccessful bidder will be returned after a reasonable time.
- No interest will be paid for EMD.
- If any offerer seeks exemption from payment of EMD, the same shall be made with required documentary evidence in support of it.
- In the absence of non-satisfactory evidence for exemption of EMD request, the offer will be treated as offer without EMD.
- Offers without EMD will be rejected.

8. SECURITY DEPOSIT:

The successful tenderer will be required to deposit a Security equivalent to 5 % of value of purchase order placed with in 30 days from the date of the order by means of DD drawn on any Nationalized Bank or Scheduled Bank in favour of "TAMILNADU MAGNESITE LIMITED" payable at SALEM. The sum deposited as Earnest Money Deposit as required in clause 6 above, may be adjusted against the Security Deposit and the balance amount should be deposited by successful tenderer within 30 days of the order.

9. FORFEITURE OF EMD:

If the accepted tenderer fails to remit the Security Deposit within the above said period or retract after opening of the tender, or fail to respond to call for negotiation of rates, terms and conditions, the Earnest Money Deposit already paid will be forfeited to the TamilNadu Magnesite limited and the tender will be held void.

10. INTEREST ON EMD & S.D:

No interest will be payable either on the Earnest Money Deposit mentioned in Clause 6 above or on the Security Deposit mentioned in Clause 7 above.

11. AGREEMENT:

Any offer made in accordance with the terms of this tender, when accepted by Tamilnadu Magnesite Limited, will constitute a contract between the parties.

The successful tenderer will be required to execute an agreement in the prescribed form embodying the terms and conditions for the execution of the tender within thirty days from the date of receipt of intimation of acceptance of the tender.

12. FORFEITURE OF S.D:

If the tenderer fails to act upon the tender or backs out after his tender is accepted, his security deposit mentioned in Clause 7 above will be forfeited to the Tamil Nadu Magnesite Limited.

13. AWARD OF CONTRACT:

Any offer made in accordance with the terms of the tenders when accepted by Tamil Nadu Magnesite Limited will constitute a contract between the parties.

Award of contract will be made at sole and absolute discretion of the Tamil Nadu Magnesite Limited which shall be final. No correspondence will be entertained with the unsuccessful tenderers.

14. GUARANTEE:

The tenderer shall undertake to replace machinery or any portion thereof which has been lost/damaged, while in transit due to faulty or improper packing or failure to obtain sufficient proof for having entrusted correct quantity ordered and despatched by the tenderer which may ultimately result in non-delivery or short delivery and consequent non-recovery of shortage from the concerned transport operators. The tenderer should also furnish a guarantee for a period of one year against all manufacturing defects and agree to replace the machinery/parts which for any portion thereof may be found to be not useful for the purpose for which it was purchased, either due to defective manufacture or otherwise. Delivery of the full replacement of machinery/parts should be effected free of cost of Company's unit as noted in the purchase order.

15. COMPLETENESS OF EQUIPMENT:

The tenderer should state whether the equipment offered is complete by itself. If in their opinion certain components or accessories are necessary to go with the type of equipment tendered by the tenderer, they may quote them as extras.

16. PRE DELIVERY INSPECTION :

The supplier has to arrange for a pre delivery inspection of the machinery at his works. The technical personnel of TANMAG shall inspect and clear the machinery before it is dispatched to the site.

17. LIQUIDATED DAMAGES:

At the rate of ½ % per fortnight subject to maximum of 5% per annum on the total value for the delayed supply will be levied and such liquidated damages should be adjusted against the security deposit/price payable for machinery for beyond delivery period mentioned in the purchase order.

18. ERECTION AND COMMISSIONING AND PERFORMANCE TEST:

The machinery must be commissioned at the TANMAG quarries as specified in the purchase order and conduct trial test by engaging engineers at your expenses to fulfill the guaranteed performance.

The successful tenderer shall provide training for 5 working days to TANMAG operator / personnel for each excavator purchased separately, at quarry site, free of cost.

19. Manuals / pamphlets and technical details, should be submitted along with offer.

20. Offerer should enclose the list of customers to whom they have supplied the above type of equipments along with copy of recently executed orders.

21. Offers shall be considered carefully & Short listing of acceptable offers will be done on merits of technical points which includes the following and the selection criteria basis.

On the technical points

- (a) Reputation of the party in similar nature of work. (should have adequate experience in this line of manufacturing).
- (b) Based on the population of similar equipments/ systems supplied by the party, in our region, their performance report by users. (Documentary proof should be submitted from minimum one from your customers).
- (c) Establishment, infrastructure, financial back-ground, manufacturing facilities, quality, technical know-how, staff pattern involved in the manufacture etc.

on the commercial points

- (a) Price split-up details with material cost, erection & commissioning charges wherever applicable.
- (b) Price competitiveness.
- (c) Income-Tax Clearance Certificate of the offerer.

on general points

- (a) Delivery time required for complete supply including erection & commissioning.
- (b) Guarantee period for trouble free working, without any failure.
- (c) Clear offer with maximum civil, mechanical & electrical details forming an offer proper & complete without any clarification.
- (d) Performance Guarantee.

22. EVALUATION CRITERIA

Necessary literature on spare parts catalogue and operation manual for the machinery should be supplied free of cost, for each of the excavator supplied.

25. Canteen facility will be provided on chargeable basis only to supervisory staff.

26. COURT JURISDICTION:

The courts situated within Chennai alone shall have jurisdiction to decide all disputes and claims that may arise between parties.

27. Accommodation will be provided on chargeable basis subject to approval and availability of suitable accommodation.

DELIVERY PERIOD :

We require the equipment to be commissioned immediately. Hence, lead time required for supply and commissioning should be clearly indicated.

For any delay over the agreed period will attract Liquidity Clause @ ½ % (Half-a-percent) per fortnight subject to a maximum of 5%.

GUARANTEE :

(a) The equipment to be supplied by the Tenderer should be guaranteed for design, workmanship for a minimum period of 12 months of effective working from the date of commissioning.

ARBITRATION :

If at any time, any question, dispute or difference whatsoever shall arise between TANMAG and Contractor arising out of (or) in connection with the Contract, the parties thereto shall use their best efforts to settle such question, dispute or difference amicably by mutual negotiations.

If agreement could not be reached, the disputes shall be referred to sole arbitrator, who shall be the Chairman and Managing Director of TamilNadu Magnesite Limited. Arbitration shall be in accordance with the provisions of Indian Arbitration Act, 1940.
