Manager (Marketing), Tamilnadu Magnesite Limited, Registered Office: 5/53, Omalur Main Road, Jagir Ammapalayam (PO), Salem - 636 302 for the sale of Dunite (Soft), Dunite (Coated), Dunite (Residual), Dunite (RKD/SKD), Raw Magnesite (Y₃ & Y₄ grades), Raw Magnesite Slaty (RMS), Raw Magnesite Dust (RMD), Smoke Chamber Dust (SCD) and Belt Picking Plant Residual (BPPR) available at Rotary Kiln Division (RKD) and Mines of TANMAG.

2. TERMS AND CONDITIONS:**2. (A).ELIGIBILITY TO PARTICIPATE IN THE TENDER:**

- i. Buyers from domestic / foreign countries.
- ii. The bidders should have valid PAN, GST Registration certificate.
- iii. For RM (Y3 & Y4) material, bidders should have a valid IBM registration certificate.

2. (B).THE FOLLOWING CATEGORIES WILL NOT BE ELIGIBLE TO PARTICIPATE IN THE TENDER:

- i. Bidders / Buyers / Customers / Participants who came to adverse notice in dealing with TANMAG either as buyer or in any other capacity.
- ii. Bidders / Buyers / Customers / Participants who are defaulters in terms of non-payment for the proforma invoices raised for TANMAG products such as Dead Burnt Magnesite (DBM), Lightly Calcined Magnesite (LCM), Dunite and other products of TANMAG for which penal action taken / caused loss to TANMAG in any of the earlier tenders, and black listed from participating in future tenders.

- iii. Those who have indulged in malfeasance during their earlier business transactions with TANMAG.

3. TENDER SUBMISSION:

- i. Tenders should be submitted online through Tamil Nadu Government Tender e-portal URL, address <https://tntenders.gov.in>.
- ii. Uploading of application in the location other than specified above shall not be considered. Hardcopy of application shall not be entertained.
- iii. The bidder has to remit the EMD as 1% of the tender value through online option **“Pay online” e-portal. The Bidder** may avail exemption by producing MSME / NSIC valid certificates, Electronic Bank guarantee (eBG), etc., The copy of RTGS / NEFT remittance needs to be submitted to Tamilnadu Magnesite Limited, Salem, Tamil Nadu through online. Also, they have to enclose the proof for exemption availed for EMD by uploading the copies as mentioned in the Annexure-IV.
- iv. Bidders are requested to upload the digitally/manually signed tender documents along with the scanned copy of **RTGS / NEFT** for EMD remittance details and copy MSME / NSIC valid certificates, Electronic Bank guarantee (eBG), etc., as a proof of EMD exemption. Bid Documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- v. If any clarification required from the bidder, about the deficiency in his uploaded documents in Technical bid he will be asked to provide it through e-mail/Tamil Nadu Tender portal. The bidder shall upload the requisite clarification / documents within the time specified failing which tender will be liable for rejection.

4. TECHNICAL BID:

- i. Covering Letter for Purchase of TANMAG products (Annexure-I) duly signed by the bidder.
- ii. Details of Bidder (Annexure-II) duly signed by the bidder.
- iii. Item wise D (S), D (C), D (R), D (RKD/SKD), RM, RMS, RMD, SCD & BPPR has to be quoted and duly signed by the bidder (Annexure.III).

- iv. Details of EMD remittance for bidder quoted quantity and exemption claimed (Annexure.IV) duly signed by the bidder.
- v. Scanned copies of RTGS/NEFT remittance details for EMD and scanned copies of MSME / NSIC valid certificates, Electronic Bank guarantee (eBG), etc..as proof of EMD exemption.
- vi. Copy of certificate of Registration of incorporation/proof of constitution of Firm, LLP, Proprietorship etc., like PAN card and GST registration certificate.
- vii. The bidder has to quote their rate per MT for each product and quantity quoted by them separately in the BoQ (Annexure-IX) excluding GST.
- viii. The maximum quantity may be quoted as per quantity offered in the tender by TANMAG for the various grades of Dunite (Soft), Dunite (Coated), Dunite (Residual), Dunite (RKD/SKD), Raw Magnesite (RM), Raw Magnesite Slaty (RMS), Raw Magnesite Dust (RMD), Smoke Chamber Dust (SCD) and Belt Picking Plant Residual (BPPR). The bidder shall mention clearly by item wise the quantity quoted in Annexure-III.
- ix. If the successful bidder has quoted for quantity less than the quantity offered by TANMAG, the balance quantity will be offered to other bidders in descending order of bids to match H₁ rate.
- x. The successful bidder must remit the amount for the quoted quantity within 2 days of issue of “Proforma Invoice (PI)”. After remitting the amount, the successful bidder should lift the entire quantity of material within 40 days from the date of issue of “Award of Contract (AOC).”
- xi. If the bidder fails to remit the amount and lift the quoted quantity within the specified time, the EMD amount remitted by the bidder will be forfeited besides cancellation of award of contract. In addition, the bidder will also be black listed in TANMAG. Then the quantity will be offered to other bidders in descending order of bids to match H₁ rate.
- xii. In some unavoidable circumstances, if the bidder has lifted partial of quoted material within the stipulated time, the demurrage will be levied @Rs.10/-

per MT per day for the balance quantity to be lifted, after completion of stipulated time to till date of lifting the entire quoted quantity.

- xiii. The interested bidders may inspect the quantity of our products which allotted for tender at RKD and Mines premises at the respective stockyards after getting previous approval from TANMAG before the tender opening date. (Refer clause (9) of this tender document).

5. FINANCIAL BID:

- i. The Bidders have to quote separate rates (excluding GST) for each item wise per MT listed in this tender document, at ex-factory (RKD) of TANMAG in above mentioned locations in the BoQ format (Annexure-IX) given in the e-tender portal in www.tntenders.gov.in
- ii. If the Tenderer fails to comply with any of the above conditions, their offer will be totally rejected.
- iii. It shall be the responsibility of the persons submitting the tender to ensure that the tenders have been submitted in the formats and as per the terms and conditions prescribed in the e-tender document and no change is made therein before submission of their tender. In the event of any doubt regarding the terms and conditions/format, the persons concerned may seek clarification from the Asst. Manager (Marketing) through e-mail. - iv. Tenderer should go through the various clauses mentioned in tender document and annexures point by point and data shall be furnished in all respect. Ambiguous offer shall be liable for rejection.
- v. The Rates shall be quoted in the format provided and no other format is acceptable. The price bid has been given as a standard BoQ format with the tender document. The same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the unprotected cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the file name. If the BoQ file is found to be modified by the bidder, the bid will be rejected.

6. QUOTATIONS:

- i. The Foreign/Domestic bidders are requested to quote their rates per MT in INR only (excluding GST) at ex-stockyard for each item wise separately in the BoQ (Annexure-IX) format given in the e-tender portal. The RKD plant is about 12 Km & Mines is about 15 Km from Salem.
- ii. The offered quantity of various grades of Dunite (Soft), Dunite (Coated), Dunite (Residual), Dunite (RKD/SKD), Raw Magnesite (RM), Raw Magnesite Slaty (RMS), Raw Magnesite Dust (RMD), Smoke Chamber Dust (SCD) and Belt Picking Plant Residual (BPPR) of various grades and the corresponding upset prices are mentioned in this tender document (Annexure-III).
- iii. The bidders awarded for sale of Dead Burnt Magnesite (DBM) shall lift the entire offered quantity within stipulated time on making an advance payment. The advance payment shall be made within 2 days from the date of issue of “Proforma Invoice (PI)” by TANMAG.
- iv. Rate should be quoted item wise for products offered by TANMAG. The rates shall be specified in BoQ in figures and the Rates shall not be altered.

7. LANGUAGE OF THE TENDER:

The Tender prepared by the bidder as well as all correspondences and documents relating to the Tender shall be in English only. If the supporting documents are in their regional language other than English/Tamil, the notarized translated English version of the documents should also be enclosed. Tender received without such translation copy will be rejected.

8. PURCHASE OF TENDER DOCUMENT:

The tender document shall be downloaded at free of cost from the website www.tntenders.gov.in/nicgep/app. The bidder should give a declaration for not having tampered the Tender document downloaded (as per Annexure V).

9. **SITE VISIT:**

Intending bidders shall visit the site (RKD factory & Mines) on working days from 8 am to 5 pm from 21.07.2026 to 03.08.2026 and shall get themselves thoroughly acquainted with the local site condition, which will help the bidders to consider all such factors during the estimation for performing the contract. TANMAG holds no responsibility for arrangement of transportation / accommodation facilities for the bidders during their site visit except for giving permission to access the premises at the stipulated time period. For undertaking site visit, bidders are requested to contact Manager (Mines) / Factory Manager (RKD) / Asst.Manager (Marketing) through mobile 9442700734 / 9443051717 / 9442700724 for site visit.

10. **CLARIFICATION ON THE TENDER DOCUMENT:**

The Management will review the same and where information sought is not clearly indicated or specified in the tender documents, will issue a clarifying bulletin on www.tntenders.gov.in/nicgep/app. The Management will neither make nor be responsible for any oral instructions. Request for clarification should be brought to the notice of the Tender Inviting Authority, in writing, before 5 days in advance to opening the technical bid.

11. **AMENDMENT OF TENDER DOCUMENT:**

TANMAG whether on its own initiative or as a result of a query, suggestion or comment of an Applicant or a Respondent, may modify the tender document by issuing an addendum or a corrigendum at any time before the opening of the tender. Any such addendum or corrigendum will be communicated through <https://tntenders.gov.in/nicgep/app> and uploaded the same will be binding on all Applicants or Respondents or Bidders, as the case may be.

12. AUTHORISATION OF THE BIDDER:

The tender document should be signed on each page by the bidder or by the person who is duly authorized for the same by the bidder.

13. SUBMISSION OF TENDER IN TWO COVER SYSTEM:

- i. The eligible bidders shall participate in bidding only by online mode through the website <https://tntenders.gov.in/nicgep/app> under two cover systems (i.e. (i) Technical Bid and (ii) Financial Bid in the prescribed format.
- ii. Bidders are allowed to submit the bid on or before 06.00 PM on 03.08.2026. The tn.tender portal will not allow any bidder to attempt bidding after the scheduled date and time of bid submission. The submission of bids physically is not permitted.
- iii. All the documents in support of eligibility criteria are to be scanned and uploaded along with the tender documents in the designated website.
- iv. The bidder should quote the price for each item in the BoQ as per the format given in the e-tender cum Auction portal (Annexure-IX).
- v. To participate in the bid, the bidder shall have a valid Class 3 Digital Signature Certificate (DSC), obtained from the certifying authorities enlisted by Controller of Certifying Authorities (CCA).
- vi. Every page of the tender document should be signed and uploaded, in token of having accepted the tender conditions. Failing which the tender will be rejected summarily.
- vii. No bidder shall submit more than one bid.
- viii. The bidders shall be responsible for all of the costs associated with the preparation of their bids and their participation in the Bid Process. TANMAG will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

- ix. TANMAG shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to the tender document or the Bidding Process, including any error or mistake therein or in any information or data given by TANMAG.

14. EARNEST MONEY DEPOSIT & TENDER SUBMISSION:

- i. The EMD amount for this tender is Rs. 9,58,824/-.
- ii. The EMD exemption can be availed by enclosing the relevant valid certificates such as MSME / NSIC certificates, Electronic Bank guarantee (eBG), etc... issued by the competent authority along with Technical offer.
- iii. EMD is fixed as 1% of the tender value against the quantity offered by TANMAG for those who are not availing EMD exemption by producing above relevant documents.
- iv. The Bidder has to select the payment option as “**pay online**” to pay the EMD amount. Only after payment of EMD, bidder will be able to encrypt/upload their bids. In order to avoid last minute lapses, it is recommended to make payment and submit the bid as early as possible. TANMAG is not responsible for any sort of difficulty faced / failure in submission of bids online by the bidder.
- v. Tenders should be submitted through online e-portal URL, address <https://tntenders.gov.in/nicgep/app>
- vi. Bid submission through online ends on 03.08.2026 @ 6.00 PM.
- vii. Hard copy submission of tender (or) submission of tender in any other portal than specified portal shall not be entertained.
- viii. Non-submission / Non-remittance of EMD within the stipulated date and time will entail outright rejection of bids.
- ix. Online payment gateway has been enabled for Tamilnadu Magnesite Limited, Salem in TN Tenders Portal. All the payments for the tenders will be carried out by bidders only through online payment mode. Bidders shall select the option for payment of EMD as Online [download the PDF document online payment] available

from the website <https://tntenders.gov.in/nicgep/app> under Announcements (Bidder Manual for Online Payment of Tender related Fees in e-Procurement Portal). The Announcements is available in left side of the Home Page. The bidders should follow the Instructions step by step for online payment submission.

- x. The EMD amount paid shall be the exact amount. The amount shall be transferred through online payment gateway. If excess or short, the tender status will be shown as invalid.
- xi. The EMD will not carry any interest.
- xii. The EMD amount will not adjust for the payment of materials awarded to the bidders.
- xiii. In order to avoid any issues and last minute delay in processing of payment online, bidders should ensure payment of EMD, 72 hours in advance. TANMAG will not be responsible for any sort of difficulties or delay faced by the bidder during submission of bids online, due to local issues.
- xiv. Any other mode of payment of EMD shall not be accepted except valid MSME/NSIC certificates (or) Electronic Bank guarantee (eBG) (only for availing EMD exemption).
- xv. The bidders will be evaluated only if payment status shows “**Success**” during bid opening. It is necessary to click on “Freeze bid” link/icon to complete the process of bid submission, otherwise the bid will not get submitted online and same shall not be available for viewing/opening during technical bid opening.

Refund of EMD of unsuccessful bidders:

The EMD paid by the bidder will automatically be deposited in the “Pooling Account” of the State Government only and not in TANMAG’s account. 15. PRICE BID (BoQ):

- i. The price bid should be submitted only in electronic form as per the prescribed format given.

- ii. The price bid should not be altered and should not contain any commercial conditions. Variation in the commercial terms and conditions of the tender will not be accepted.
- iii. Each price is valid for the above mentioned TANMAG products for each item for a quantity of MT (excluding GST).
- iv. Rate should be quoted item wise for products offered by TANMAG. The rates shall be specified in BoQ in figures and the Rates shall not be altered.

16. VALIDITY:

The rate quoted for the products are only for the quantity offered by TANMAG as mentioned in the tender document clause (1).

17. OPENING AND TECHNICAL EVALUATION OF THE TENDER:

- i. The tenders received up to 03.08.2026 @ 06.00 PM will be taken up for opening. The technical bid will be opened through online at 03.30 PM on 04.08.2026 at the Registered Office of TANMAG by the Committee authorized by the tender accepting authority.
- ii. The Technical bid will be evaluated by the committee of TANMAG in terms of the qualification criteria. The committee reserves the right to disqualify any of the tender in case the Committee is not satisfied with the documents furnished, including the past performances.
- iii. The Bidders will be deemed to have understood and agreed that no explanation or justification on any aspect of the Bidding Process or selection will be given.
- iv. Any information contained in the bid shall not in any way be construed as binding on TANMAG, but shall be binding on the bidder if the tender is subsequently awarded to it on the basis of such information.
- v. TANMAG reserves the right not to proceed with the Bidding Process at any time without notice or liability and to reject any or all bid(s) without assigning any reasons.

- vi. If any information furnished by the bidder is found to be incomplete, or contained in formats other than those specified herein, TANMAG may, in its sole discretion, exclude the relevant offer for qualifying in eligibility criteria.
- vii. In the event that the claim of the bidder towards eligibility criteria submitted is determined by TANMAG as incorrect or erroneous, TANMAG shall reject such claim and exclude the same from qualifying in eligibility criteria. Where any information is found to be patently false or amounting to a material misrepresentation, TANMAG reserves the right to reject the bid.
- viii. TANMAG reserves the right to reject any bid which is non-responsive. Request by the bidder for any alteration, modification or substitution made in the Tender Document shall not be entertained by TANMAG.
- ix. To facilitate evaluation of bids, TANMAG may, at its sole discretion, seek bonafide clarifications from any bidder regarding his bid. Such clarification(s) shall be provided within the time specified by TANMAG for this purpose. Any request for clarification(s) and all clarification(s) in response there to shall be in writing / e-mail.
- x. If a bidder does not provide clarifications sought under Clause 17(ix) above within the prescribed time, the bid shall be liable to be rejected. In case the bid is not rejected, TANMAG may proceed to evaluate the bid by construing the particulars requiring clarification to the best of its understanding, and the bidder shall be barred from subsequently questioning such interpretation of TANMAG.
- xi. The bidders declared as qualified by the Committee, will be informed on the date of opening of Price bid through <https://tntenders.gov.in> portal.
- xii. The un-qualified bidders will be informed through <https://tntenders.gov.in> portal and their EMD will be refunded automatically from pooling Account.

18. CONFIDENTIALITY:

- i. Information relating to the examination, clarification, evaluation, and recommendation for the short-listed / pre-qualified bidders shall not be disclosed to any person who is not officially concerned with the process or not

a retained professional advisor advising TANMAG in relation to or matters arising out of or concerning the Bidding Process. TANMAG will treat all information, submitted as part of bid, in confidence and will require all those who have access to such material to treat the same in confidence. TANMAG may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/ or TANMAG or as may be required by law or in connection with any legal process.
